# **Population criteria**

- Initial Patient Population =
  - AND: "Patient characteristic: birth date" (age) >= 18 years;
  - AND: "Diagnosis active: heart failure";
  - o AND: >=2 count(s) of:
    - OR: "Encounter: encounter outpatient";
    - OR: "Encounter: encounter nursing facility";
- Denominator =
  - o AND: All patients in the initial patient population;
  - o AND: "Diagnosis active: atrial fibrillation";

#### Numerator =

- o AND:
  - OR: "Medication active: warfarin therapy";
  - OR: "Medication order: warfarin therapy";

#### Exclusions =

- OR: "Medication allergy: warfarin therapy";
- OR: "Medication adverse event: warfarin therapy";
- OR: "Medication intolerance: warfarin therapy";
- OR: "Medication not done: medical reason";
- OR: "Medication not done: patient reason";
- OR: "Medication not done: system reason";
- OR: "Diagnosis active: anemias and bleeding disorders";

# **Data criteria** (QDS Data Elements)

## • Initial Patient Population =

- "Patient characteristic: birth date" using "birth date code list" before the beginning of the "measurement period";
- "Diagnosis active: heart failure" using "heart failure code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Encounter: encounter outpatient" using "encounter outpatient code list" during the "measurement period";
- "Encounter: encounter nursing facility" using "encounter nursing facility code list" during the "measurement period";

## • Denominator =

- All patients in the initial patient population;
- "Diagnosis active: atrial fibrillation" using "atrial fibrillation code list grouping" before or simultaneously to the "measurement period";

## Numerator =

- "Medication active: warfarin therapy" using "warfarin therapy code list" during the "measurement period";
- "Medication order: warfarin therapy" using "warfarin therapy code list" during the "measurement period";

#### • Exclusions =

- "Medication allergy: warfarin therapy" using "warfarin therapy code list" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Medication adverse event: warfarin therapy" using "warfarin therapy code list" before
  or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter
  nursing facility";
- "Medication intolerance: warfarin therapy" using "warfarin therapy code list" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- o "Medication not done: medical reason" using "medical reason code list" for "Medication active: warfarin therapy" OR "Medication order: warfarin therapy";
- "Medication not done: patient reason" using "patient reason code list" for "Medication active: warfarin therapy" OR "Medication order: warfarin therapy";
- "Medication not done: system reason" using "system reason code list" for "Medication active: warfarin therapy" OR "Medication order: warfarin therapy";
- "Diagnosis active: anemias and bleeding disorders" using "anemias and bleeding disorders code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: esophageal and GI bleed" using "esophageal and GI bleed code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: intracranial hemorrhage" using "intracranial hemorrhage code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: leukemias/myeloproliferative disorders" using
   "leukemias/myeloproliferative disorders code list grouping" before or simultaneously to
   "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: hematuria" using "hematuria code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: hemoptysis" using "hemoptysis code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: hemorrhage" using "hemorrhage code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";
- "Diagnosis active: liver disorders" using "liver disorders code list grouping" before or simultaneously to "Encounter: encounter outpatient" OR "Encounter: encounter nursing facility";

## **Summary Calculation**

Calculation is generic to all measures:

- Calculate the final denominator by adding all that meet denominator criteria.
- Subtract from the final denominator all that do not meet numerator criteria yet also meet exclusion criteria. Note some measures do not have exclusion criteria.
- The performance calculation is the number meeting numerator criteria divided by the final denominator.

- For measures with multiple patient populations, repeat this process for each patient population and report each result separately.
- For measures with multiple numerators, calculate each numerator separately within each population using the paired exclusion.
